

Chippewa Valley Electric Cooperative Board Vacancy for February 2015 Election

Chippewa Valley Electric Cooperative (CVEC) members who reside in Districts 1 and 6 have an opportunity to serve on the co-op board of directors by running for a position in the February 2015 co-op election. Two positions will be up for election; current incumbents are Don Frei, Holcombe, representing District 1, and Ken Schmitt, Colfax, representing District 6.

CVEC is owned by its members and guided by directors elected from the membership. Board directors serve three-year terms and represent co-op members at monthly meetings. Candidates must meet the qualifications outlined in the cooperative's bylaws and be full-time residents of the district they represent. Two directors will be elected at the annual meeting of Chippewa Valley Electric Cooperative on February 28, 2015, at Cornell High School. Cooperative members will vote for directors in Districts 1 and 6.

Consider becoming a part of your electric cooperative by submitting your name as a director candidate in this year's election. A director must have the time to attend monthly board meeting, other special meetings, and educational seminars that are designed to keep directors informed on various aspects of CVEC and the electric utility industry. Their decisions are made in the best interest of the cooperative, and they represent the entire membership. ■

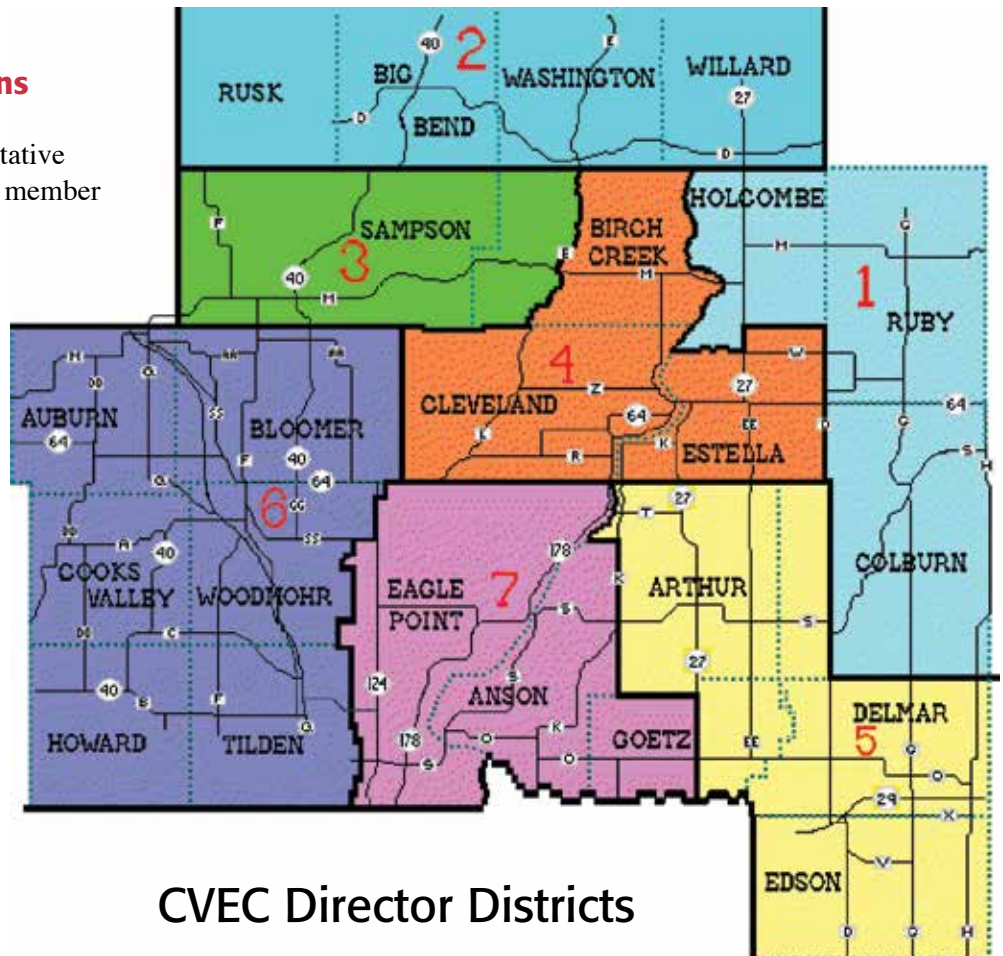
Director Qualifications

In order to serve as a representative on the CVEC Board of Directors, a member must...

1. Be a member and primary resident of the district from which elected.
2. Not be employed by or have a financial interest in a competing enterprise or business selling electric energy or supplies to the cooperative.
3. Not be employed by the cooperative.

Dual Fuel Systems to be Tested November 19

As the heating season fast approaches, we are preparing for another Wisconsin winter. This includes a test of our load management system.

If you currently participate in our dual fuel or off-peak heating program, the load management system will be tested on Wednesday, November 19 (Thanksgiving is the following week).

Your electric heating system will be shut off at 5:00 p.m. and will remain off throughout most of the evening. Heating systems will be randomly turned back on beginning at 9:15 p.m., and all systems should be back on by 11:15 p.m.

During the time the electric

heat is off, customers will rely on their backup heating system. If you experience any problems with your heating system during this test, please contact your heating contractor. If you experience any problem with our load management receiver (pictured at right), contact Chippewa Valley Electric Cooperative at 715-239-6800 or 1-800-300-6800.

This test is a benefit for you as well as the cooperative. We want to make sure your backup heating system and the load control device work properly before we get into extremely cold weather.

Take These Steps When the Power Goes Out

If the power goes out in your home there are a few things you should check before calling CVEC. A few simple steps could save you money.

Check Your Meter

Take a look at your meter to help determine if the outage is CVEC's problem or a problem within your home. A meter with a digital display will have a blank screen which indicates that the problem is on the co-op's side. When you see something displayed on the screen, this means that power is getting to the meter and it is not a co-op outage; it is an outage within your home. If you have a meter that does not display a digital reading, then check for a red light

on the lower left side of the meter. When you see a red light, this indicates that power is getting to the meter and the problem is with your own

equipment; you should check your breakers or contact an electrician. If there is no visible red light, contact CVEC to report an outage.

Check Your Breakers

Be sure to check your breakers inside your home at your electrical panel *and* also outside at your meter pedestal (if you have one). The photographs at left indicate where to find the breaker within a meter pedestal. If a breaker has been tripped, push the handle to the "Off" position before flipping it to the "On" position. It is important to check the breakers at both locations to avoid a service call if the outage is found to be your responsibility.

When you have determined that the power outage is not due to your own equipment, call Chippewa Valley Electric to report the outage at 715.239.6800 or 800.300.6800. ■

Don't Forget to Fall Back

Don't forget: Daylight Saving Time ends November 2. That's when we set our clocks back one hour and enjoy an extra hour of sleep for one night. Take advantage of this occasion to perform a few other necessary household tasks as well.



After you've turned all of your clocks back, turn to your smoke alarms to change the batteries. Batteries should be changed at least once a year; Daylight Saving Time provides a perfect annual reminder for this important safety task.

Test smoke alarms monthly by pushing the TEST button or using other procedures recommended by the manufacturer. If an alarm "beeps" to indicate low batteries, change them right away. Replace all smoke alarms at least every 10 years.

After replacing the batteries in your smoke alarms, turn to your carbon monoxide detectors and replace those batteries as well. Daylight Saving Time means colder weather is coming, and that means the risk of carbon monoxide poisoning increases as people seal up their homes and sometimes seek unsafe ways to keep warm. Ensure that your carbon monoxide detector is properly working before the cold weather sets in. ■

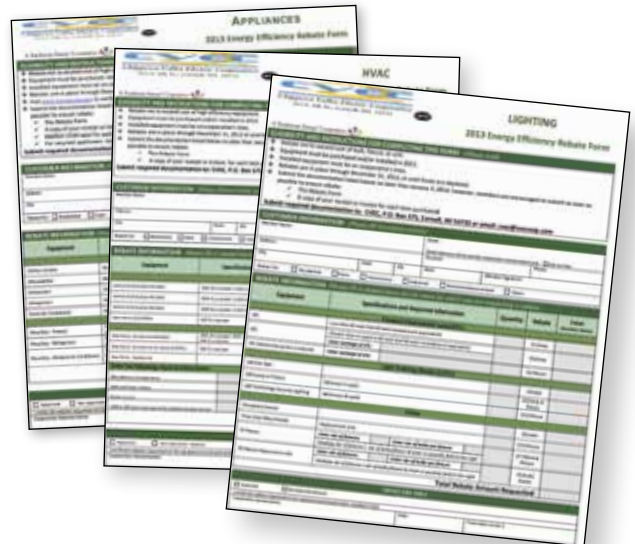
