YOUR METER MUST BE READILY ACCESSIBLE

Please, before you do any work involving the enclosing of or covering of your meter socket and the Cooperative meter, contact Chippewa Valley Electric Cooperative to make sure the work you will be doing will not cost you the additional expense to have the meter moved.

More often than we like our crew will come upon a meter that has become enclosed, either by an addition built around it or sided over (see two photos below). Those situations create a number of problems, including violating the National Electric Safety Code and not allowing access by our crew to the Cooperative meter.



When we become aware of a meter location problem, we contact the member and work to have the meter moved to an acceptable location. In most cases the member will need to install a meter pedestal (see photo above) at the member's expense. Currently, the meter pedestal costs \$645.00 installed, but the cost could be higher depending on the situation. Chippewa Valley sometimes makes payment arrangements in those instances to help out the members.
